## PERU

Casa Grace in Peru. By Eugene W. Burgess and Frederick H. Harbison. Washington, D. C., 1954. National Planning Association. United States Business Performance Abroad, 2. Charts. Illustrations. Maps. Tables. Bibliography. Pp. viii, 112. $\$ 1.00$.

The purpose of this series is to make obective studies ' of some selected cases in which U. S. business management has, in pursuance of normal and profitable operations abroad, taken positive steps toward raising living standards and helping to integrate into countries less developed than the United States the foundations of a more mature economy." The success of each business studied is to be measured against its contributions to the basic economy, living standards, institutional benefit, and cultural achievements. The first volume in this series, published in 1953, was an 88 page case study of Sears, Roebuck de México.

Much of the information in this book-especially on corporate organization, labor policy, and management problems-is not available elsewhere. W. R. Grace and Co. has been in Peru since 1904, but over half of the $\$ 30,000,000$ it has in gross fixed assets has been invested in the last eight years. This means that the book will be of most value to those readers interested in present-day Peruvian social and economic conditions. Like Casa Grace, the authors avoid politics. (J. P. H.)

Misiones venezolanas en los archivos europeos. By Joaquin Gabaldon Marquez. Mexico City, 1954. Instituto Panamericano de Geografía e Historia. Comisión de Historia. Pp. 230.

This eighth volume in the series of the Commission on History on the labors of scholars of the New World in European archives deals with Venezuela. Part one presents brief notes of the official missions of Figueredo, Vetancourt Vegas, Dominici and Froilan de Rionegro and gives a summary deseription of the documents in fifty-five volumes of transeripts secured by these scholars, which are now in the Academy of History. Part two has short accounts of the private missions of Parra Pérez, the Urdaneta Carrillos, López and Nectario María, which are followed by detailed descriptive lists of the transcripts secured. Parra Pérez worked mostly in England while the other investigators devoted their attention to Spanish archives, particularly the Archivo General de Indias. The lists reveal that the emphasis was placed on the period of the movement for independence in Venezuela.
